TOWNSHIP OF NEPTUNE SEWERAGE AUTHORITY September 18, 2024 Meeting

The meeting for the Township of Neptune Sewerage Authority was held on the above date with the following Authority Commissioners present: Harry Devine, James Mowczan, Linda Johnson, William Jones and James W. Manning, Jr. The following consultants were also present: Ms. Aldarelli and Mr. Fedorchak. In addition, Executive Director Tina Cunningham and Adam Holba were present.

Chairman Manning called the meeting to order at 6:00 p.m. Moment of Silence and Flag Salute. Chairman Manning stated that the fire exits are located in the direction that he is indicating, in case of fire you will be notified by bell and or public address system. In addition, he is obtaining quotes for cleaning of the electrical mud pits and lighting around the plant.

Ms. Cunningham requested to solicit bids for Furnishing and Delivering of Sodium Hypochlorite and Lab Analysis Services. In addition, Univar and Evoqua have agreed to one year contract extensions. Lastly, she stated that she would be working on the 2025 Budget to be introduced at the Authority's meeting in October.
