# TOWNSHIP OF NEPTUNE SEWERAGE AUTHORITY August 20, 2025 Meeting

- The Authority's Bioassay test is scheduled for next week.
- TNSA is waiting on the results of the gas sample. RVE is providing assistance.
- TNSA is reviewing the report of recommendations from the switchyard cleaning.
